There are a few things that could have been better about the set-up in the church. Victoria and Brenna have a better sense of how to place the food in the room.

There was enough of everything - food and supplies. And doughnuts and coffee.

The fundraiser netted just over \$600.

Other Business:

Library hours: Jen expressed interest in the idea of the library being open in the evenings as an adult gathering space. Millie is also keen on this idea, and has some ideas. Allison wondered about other kinds of nights, like crafts. The board is quite interested in this kind of programming. Josh suggested that this sort of thing would not need to have staff present, but could be overseen by volunteer board members. Josh will continue to think about whether adjusting the hours is necessary.

Member Concerns:

Victoria asked about the discussion of the lift that happened at Town Meeting. It was discussed several times, with lots of input from concerned townspeople. The board wants to help move forward the process, and will continue to work with the town. Everyone's goal is to restore access to the library. Millie will pick up looking for library-specific grants for accessibility.
