- Policy: Gift and Funds Policy were reviewed. No changes were made.

Old Business

- Committee Assignments: No further assignments needed.

New Business

- IMLS Staffing & Funding Issues: The State of Vermont is losing grant money on interlibrary loans. The Haston Library gets some grant money for interlibrary loans (about \$600-\$700). As of right now, the library has not felt any effects on the recent changes.
- Children's Garden: The garden needs some love wood structure is rotting.
 - Discussion was had about rebuilding with possible donations from Sticks n' Stuff or forgoing that and planting an annual (lilac tree, butterfly bush, pollinators, etc) that is self-sustaining and low maintenance.
 - Maybe adding a sand box or place for children to dig in. Lissy has a sandbox with a cover that she would be willing to donate if needed.
 - Help will be needed for demolition maybe a tractor from the Town could be used to make the process quick and easy.
 - Further research and options will be thought about for the next meeting.
- Feasibility study for childcare at the Felco Room: Deb gave an update on the Childcare committee from the Community Visits Forum from last year. They got a grant to do a feasibility survey - staff and residents of Homestead, childcare providers around town, community partners that need childcare, etc. Surveys are being taken and data collected.
 - Homestead residents have concerns about childcare in the basement so other options are being taken into consideration i.e. basement of the Franklin United Church.
 - Childcare would be primarily for infants (under age two), 8 children total.
 - Only two registered childcare providers in town.

Other Business/Member Concerns:

• Memorial Day: Library float "Color Your World"

- Float ideas: float could be black and white and everyone dress up as crayons or one color outfit.
- Jen Raynak has friends that would like to help with the book sale. Book sale will be at the bandstand in front of the Town Hall.
- Things to hand out (couple hundred needed): boxes of crayons with stickers (made by Sierra), summer reading program swag, bookmarks that kids can color, candy, etc.
- Plant Swap event: two weeks after our next meeting (mid to late May).
- Compliments were made to Josh and Sierra for reorganizing the collection of books easy to find authors/books, aesthetically pleasing. It looks great!
